MEMBERSHIP RENEWAL 2020

Dues to the Club shall be *due, payable, and postmarked* on or before on **May 1, 2020**. If dues are not paid by May 1, the member shall be placed on probation, the member's name posted at the Club's check in stand (when the Club opens for the season), and all privileges of the Club shall be revoked until said dues are paid. If the same dues are not paid by **June 1, 2020**, the member shall be dropped from the membership list after attempts by the Treasurer to contact the member to give notice of the same. Thereafter, membership may be reinstated only after tender of all indebtedness in arrears and majority vote of the Board of Directors. If the delinquent member has not resigned or been reinstated by **June 15, 2020**, the member shall forfeit his or her membership stock fee and shall lose all rights and privileges incident hereto.

The rates below apply to all members, regardless of marital status. Children under the age of 3, as of May 1, 2020 are free.
