## APPLICATION FOR MEMBERSHIP

To join the waiting list, applicants must mail this application with a \$20 application fee (check with app in mail) to the above address or emailed to [treasurer@southlandfamilyclub.com](mailto:treasurer@southlandfamilyclub.com) (and paid online). The \$20 fee will be applied to 2022 membership fee if an applicant joins when invited. The fee is not refunded to applicants who decline to join. Applicants who wish to move to the bottom of the list will be required to submit another \$20 fee. Applicants will be invited by email and/or phone. It is the applicant's responsibility to update the Treasurer with any changes in contact information. Applicants may be removed from the list if contact attempts are unsuccessful at the time of invitation.

Dues to the Club shall be *due, payable, and postmarked* on or before on May 1. If dues are not paid by May 1, the member shall be placed on probation, the member's name posted at the Club's check in stand (when the Club opens for the season), and all privileges of the Club shall be revoked until said dues are paid. If the same are not paid by June 1, the member shall be dropped from the membership list after attempts by the Treasurer to contact the member to give notice of same. Thereafter, membership may be reinstated only after tender of all indebtedness in arrears and majority vote of the Board of Directors. **If the delinquent member has not resigned or been reinstated by June 15, the member shall forfeit his or her membership and stock fee.**

Current rates are shown below. The rates below apply to all members. If married, your spouse is included in the membership. Children under the age of 3, as of May 1, are free.
